Sickness & Distress:

Yesterday (7/10) **Doris Bitting** called me to let me know how things are going with her. She had the surgery Thursday. The doctor said it would take 1 hr and 15 minutes. It took three hours. She stopped breathing when they removed the breathing tube so they had to put it back in. The breathing tube is now out and she is getting better. They might send her home today Monday July 11. She can't put weight on her leg for 6 weeks. She might have rehab for 6 weeks to get strength in her leg. She will be using a walker and just hop on the good leg. She believes this surgery will work. So we ask that you continue your prayers for her. She really believes in prayer. I am sure Get Well cards would be appreciated. Janet

Update 7/30: The doctors thought it better that Doris remain in the Wynscape Nursing & Rehabilitation Center, 2180 Manchester Rd, Wheaton, IL 60187 until she gains some strength and gives the grafted bone a chance to take. She will be there about 3 more weeks. She can only put minimal weight on her leg. She has had her staples removed but she is still wearing a large brace (24/7) to keep her leg straight during the healing process. (Yuck, sounds totally uncomfortable). Larry V

Christopher Hodapp: (7/13) Most of you know by now that I was diagnosed with stomach cancer back in March. Does caught it quite by accident and very early. I've been through 9 weeks of chemotherapy, followed by a month long detox period (because, you know, it's poison). And now today—finally—they wheel me into surgery to remove all, or at least a major chunk, of my stomach. Update: (7/25): I am officially home after post-surgery recovery, and am again surrounded by the warm embraces of my bride and my poodle. So far the news is excellent. Almost two weeks ago, as the mask went over my face and the lights went out, my surgeon had anticipated removing all of my stomach in an effort to eradicate the cancer that was growing right at the connection between my esophagus and stomach. But once he perforated me across 270° of my total circumference (apparently with a Craftsman jigsaw) and started stomping around in my abdomen (apparently in cleats), it seems my chemotherapy had done more to stop the cancer in its tracks than he'd first thought. The result was

that he was able to leave me with a decent sized stomach (actually larger than what I had after lap band surgery last year!), and remove 3 inches or so from my esophagus. He took a fistful o' lymph nodes out, just for laughs, and the preliminary pathology report is that there was just one microscopic sliver of cancer in one lymph node, and that is the extent of the spread. To translate, that's the greatest news ever, and similar in tenor to the whizzing of a bullet sailing past my hairless head. Oddly, I still have a rubber hose with a small valve growing out of my belly that, shirtless, makes me appear to be a cherubic hot water heater, and clothed, a shoplifter. The best explanation I can get is that it's for "emergencies." I am apparently stuck with this odd accessory for the next two months. Otherwise, my collection of scars look like a human interactive map of Peru's Nazca lines, with tiny scrapes and cuts in enough random spots all over to convince me that someone overturned a drawer of silverware on me by accident. Recovery has been pockmarked with dazzling piles of narcotics and some truly startling hallucinations. At various times, I have been convinced I was in San Francisco, Seattle or San Diego, proving that drugs largely remain a West Coast fascination. And if it's all the same to everybody, I'd just as soon not have any more surgery again, like, ever. I still sleep more than I am awake, so I'm not being anti-social—just dancing the Oxycontin Meringue. But to give you some idea, this morning I felt just as fresh and prone to writhing in torment as I did the day after surgery, and I'm told to expect 5 to 6 more weeks of this before I feel like doing complex activities like changing from SvFy to the Weather Channel. On a pain scale of one to ten, with one being a baby unicorn gamboling in a field of buttercups, I am closer to the ten end, which is the equivalent of being hurled into the Stygian Pit at the end of a largish toasting fork, while being serenaded by the entire annoying cast of Glee with a selection of Neil Sedaka tunes. I'm at least slowly regaining my ability to form compound sentences. And, I am sufficiently emboldened by each day's progress to think that by the month's end I can tell friend, brother and attorney Michael Halleran that there's no need to sue anyone, after all. Again, Alice and I are both hugely appreciative of everyone's cards, letters, emails, prayers and good wishes, and I thank all of you. Please bear with me for the next few weeks if I seem unresponsive to messages or fail to answer the phone. I'm probably on a magic carpet ride to Seattle.

Robert C. Reicher, a 50-year member and long time recorder of Michigan City York Rite will be going in for colon cancer surgery on August 8th. Please keep Bob and Barbara in your prayers. **Update**: Bob had several inches of his colon removed.

Larry, update on Bob Reicher. Went through surgery well to remove bad areas of Colon and now is in rehab for about a week. All seems to have gone well for him. Maybe he will get to go home shortly. He is now home and doing pretty good.

Robert Dove, brother of Jim Dove had a stroke and is now at LaPorte Hospital trying to find out what caused it and to get him back to health. Right now he has no control over his left side of the body. Doctors are still looking at the tests to determine the cause.

<u>Steve Arlington's Father</u> was diagnosed with B-cell type blood cancer, and they found a tumor on his pituitary gland. He spent two months at the Rush Medical Center in Chicago and recently has been moved to the Lifecare Center in Valparaiso for physical therapy. He is 71, and the therapy is needed to build his strength while taking the chemotherapy. Steve and his family would truly appreciate your prayers.

Phillip Ritter, Brother of Michael D. Ritter, GCG, was in a serious car accident up in Michigan on Saturday the 13th.

<u>Update:</u> Just to being you up to date. Phillip is OK and is home. His truck is totaled. The individual that was hit was taken to the hospital and we have not heard how she is doing at this time. Sincerely, Michael D. Ritter

Robin "Robo" Smith, Carson Smith's Brother.

Tuesday, August 2, 2011: I do have a bit of an update on Robin Smith, Carson's brother, who was critically injured in a motorcycle accident. He has suffered a closed head injury, broken pelvis, broken ribs, and a broken wrist. As far as I know, his condition remains critical. Please continue to pray for Rob and his family.

Update 8/3: Robin "Robo" Smith is at the Neuro Critical Care Unit on the fifth floor of Methodist Hospital. He is in shock, having suffered a closed head injury with subdural hematoma, fractured wrist, rib and pelvis. Doctors are treating neurological, respiratory, cardiological and hematological failure, and have assigned a 60-80% mortality risk. Carson.

Update: 8/4: Robin "Robo" Smith has had no change in status, but he was taken into surgery from 2:00 PM to 4:00 PM on Wednesday, August 3, to have his pelvis pinned together and held in place with an external fixator. Carson.

Update 8/5: Robin "Robo" Smith has brain stem function, and he is able to breathe, but he requires ventilation to keep his air passages cleared. Sadly, preliminary test results indicate that he has no cortical function. And while laymen are fond of saying, "The first 72 hours are the most critical," the attending physician assures me that we will not really know where we are going for several days.

Update 8/6: Robin "Robo" Smith has had no change in status, he remains unconscious, he has brain stem function, but he has no cortical function, he does not respond to sound, and his eyes do not respond to light, despite the fact that is being reported on Facebook that he is "stabilized," or that he is "improving," or that "his coma was induced." Carson.

Update 8/9: Robin "Robo" Smith has had no change in status, and he remains unconscious, he has brain stem function, but he has no cortical function, he does not respond to sound, and his eyes do not respond to light, but with a week's worth of data, it has been determined that Robo has sustained significant Diffuse Axonal Brain Injury. <u>Virgil Humphrey:</u> Well, I haven't talked or made contact with you for some time and thought I should let you know where I am with my surgery of July 9th. The cancer is gone!! We're in the recovery mode and doing quite well, though I haven't gotten back to a full schedule as yet. I'm working on it. Still have a seep hole in the belly and it is supposed to be healing and then I can have the staples removed. Recovery is slower that I would like for it to be, but Doc says I am doing great and keep up the good work. My next apt with him is on the 22 of August and again, hopefully he will be able to remove the staples that day. I have had an excellent nurse in Janice. She has been very special to me these last few weeks and we are both so very thankful that we can look back on this and see perhaps that we have many more years to put up with each other again. One never knows about cancer, but the doc says my prostate cancer is gone. Will have a PSA test in about 60 days or so and see what the reading is for that. Virgil.

<u>Archie Smallwood:</u> Grand Commander of Kentucky was admitted to Clark Memorial Hospital in Jeffersonville, IN today and had a 6 MM Kidney surgically removed. They also found a blockage in his heart. They can't do anything about his heart until he recovers from the Kidney Stone. He should be out of the Hospital in a couple of days and then recoup at home. 
Robin Rea "Robo" Smith died at Methodist Hospital at 5:30 PM on Friday, August 12, as the result of injuries sustained in a motorcycle accident at West 56th Street and Georgetown Road at 4:30 PM on Tuesday, August 2, 2011. He was the son of Merritt W. "Redd" Smith of Plymouth, and Sally E. (Land) Smith of Knightstown, and the younger brother of Carson C. Smith. Robin was born in Rushville on Sunday, July 22, 1956. His family lived in Knightstown for five years, and moved to Indianapolis in 1961, where his father was a Vice President in the National Accounts Division of the Indiana National Bank and, later, President and CEO of Baldwin & Lyons, Inc. "Robby", later known as "Rob", and finally "Robo", attended John Strange Elementary School (1962-68), Northview Junior High School (1968-71), North Central High School (1971-74), and Indiana University (1974-75). He worked for the Carter-Lee Lumber Co., Hall & House Lumber Co., Furrow Building Materials, Morgan-Wightman Supply Co., Advance Printing Co., Specialty Coating Systems, and most recently, Thermal Structures. A Harley-Davidson enthusiast, he was a member of ABATE of Indiana, the Harley Owners Group (HOG), the Fukarwee Tribe, and the Bored Meeting. He is survived by his brother Carson C. (Patty) Smith, nephew Alexander C. (Steffanie) St. John, and nieces Sara and Liddy St. John. In lieu of flowers, memorial contributions can be made to the Methodist Health Foundation, P.O. Brother Nelson King passed away peacefully this morning, August 17, 2011, according to a brief statement by his wife Ellen and his daughter Vicki Rout. Nelson had fallen and was hospitalized over the weekend. He was released to go home Sunday, but fell again, breaking his right shoulder and collarbone, and was readmitted yesterday. Funeral arrangements have not yet been made. Nelson served as editor of the Philalethes Magazine from 1994 through 2009. From his website: Born June 13, 1945 in Montreal, received his primary education in Perth Ontario, and graduated from Banting Institute, University of Toronto, 1967. Married to Ellen, and had two children, Christopher, and Victoria and two granddaughters. Nelson was appointed Assistant Editor in 1992 and Editor in August 1994] of The Philalethes Society Journal of Masonic Research and Letters, the first non-United States Citizen to hold these positions. He was also only the second Mason to ever hold the position of President and Editor of The Philalethes at the same time. He retired as Editor in June 2009. Nelson was a well-known Masonic speaker. Nelson developed the highly successful Internet Masonic Leadership

Course. His book "Confessions of a Born Again Fundamentalist Freemason" has become a Masonic Best Seller. VoicePrint®, The National Broadcast Reading Service Inc. an international broadcasting reading service for the visually impaired has recorded some of his historical articles. Nelson was instrumental if the formation of the Masonic Relief for Cuba Committee. And he served as the Executive Director of that program. He was also one of the few Canadian Freemasons, listed in latest Edition of the "Who is Who of Freemasonry.
