#### John Bridegroom's Daughter Phoenix, Arch 1 Officer Grand Council

**Update 5/1:** Last night was a tough one for all of us, but especially Phoenix. She had 4 seizures in total, the longest lasting over an hour and the last one around 2:30am. There is a spot on her brain that is old and healing, but they think it is what is causing these episodes. Though they are scary, they don't seem to be damaging they say. She remains fairly cognitive during them, which is a bit unique for a seizure, able to talk somewhat and understand us. They involve severe twitching of her right arm and right side of her face, and her eyes. They have again increased her anti-seizure medication, and we are hopeful it will begin to manage/prevent these episodes. Thank you all for your prayers and kind words. John

**Update 5/1:** the courses of medicines that have been used this week have prevented any full seizures for a few days, which is good news. She is still having constant local seizures in her right arm. This is keeping her exhausted, & has prevented her from being able to use/move the arm or hand at all. She's got a lot going on right now & feels miserable. Boo.

**Update 5/7:** Today I feel like I got some answers that make sense. A seizure specialist came to see us today & said that although Phoenix definitely had many seizures, the movement in her right arm/hand is due to an aggravated brain...which is different. She hopes that using daily meds & over time, this will stop. Phoenix will be getting another MRI this week to check up on the aggravated area. She also has severe mucusitis, a side effect of chemo, which has caused sores in her mouth & GI tract. Although painful, it is good to know why she feels so bad, can't eat, continues to vomit, & has a hurty bottom.

**Update 5/11:** Phoenix's seizure & arm tremor activity have almost resolved completely. She will now be taking 2 seizure meds daily, Keppra & Vimpat. She has regained some minor movement in her arm, which makes us hopeful that she will make a full recovery. She is still hurting from the mucusitis & general fatigue caused by chemo & low blood counts. This morning she has been awake & smiling, & that is a great sign. She remains on IV nutrition until we can get her to eat & drink. She has been given a steroid cream for her full body rash (drug reaction) & it seems to be helping. The bitter sweetness of her feeling better, is that she has a round of chemo & a spinal just waiting for her counts to recover. Thank you for all the prayers & get well wishes! We cannot wait to get back home soon.

<u>Update 5/23:</u> Phoenix's chemo, labs, & exam went well yesterday. They want her up & moving more, & think that will help stimulate her appetite. Today she will see her eye doctor for a checkup, & tomorrow she goes back for a spinal & more chemo. We are pretending to be on vacation since we are at a hotel.

This would leave him bed ridden for a period of time for it to heal up before they could replace his old joint with a new joint. This would take several weeks for recovery but looks as though this is what they may have to do. He indicated that he would certainly welcome visitors starting this Wednesday thru next Thursday as Sandi will be at Indy for Grand Lodge of Indiana with her duties there.
