<u>Update 8/17:</u> Good news! Gary is out of hospital, at home and sitting in chair and making a few phone calls. He is doing real well. No sign of cancer now. Hoping that old kidney takes over and does its part. Please continue keeping Gary and Mary Jo in your prayers.

<u>Emily Van Natter's dad</u> is undergoing a major surgical procedure at VA Hospital in Indy today on his heart. Please keep the family in your prayers for success and good recovery.

<u>Update 9/14:</u> Keep Emily Van Natter and family in your prayers. Her dad has had some secondary complications from his heart surgery and now is believed to be septic - blood infection. The surgery is scary enough, but this makes it ultra serious. I'll post updates as I receive them. Emily

<u>Update 9/15:</u> From Emily Van Natter: Update on my dad: He's septic and having trouble finding an antibiotic to treat it. He has the bacteria Serratia that's causing the sepsis. He's on oxygen and his kidneys aren't functioning at full capacity. His surgery overall went well. He's on insulin for now and will need blood soon. He can't keep food down. He was to leave ICU yesterday and has three days added.

Dad had a good day today. He was up walking and playing cards with my mom. They removed his pick line today as well. Not out of the woods but closer to it. Thank you for your thoughts and prayers! Emily Van Natter

<u>Update 9/17:</u> Thank you for all your prayers. My dad will likely be discharged to HOME either tomorrow or Wednesday! He's itching for a steak or a peanut butter shake but remains on a clear liquid diet. He's no longer "technically" in ICU but remains in his ICU room because there are no rooms on the step down unit. How's that for answered prayer!!! He's anxious to be home and to have his back surgery. Emily

I'm getting along pretty good. I try walking around house about two hours a day, then back on the cane. I really use it to help not to fall. It's better that not being able to walk at all. I do drive and go into town and walk. But I can't climb steps, so that keeps me from going to lodges that have to use stairs. But I'm gaining and will be dancing before too long. Ha ha ha! Mickey Borchert: See what I did today (9/26)! Fell up the curb. I have a black eye, sore ribs, sore elbow and sore knee. I also bent my glasses. Mickey

<u>Sally Brindle: 9/30:</u> For those of you who don't know, my wife Sally had a hip replaced this morning. Long-planned and long-awaited, it corrects a problem she has had since birth but which only surfaced in the last few years due to the cartilage in the joint wearing out. The surgery began around 7:30AM and was completed about half an hour ago without any complications. Sally is in recovery now and should be in a regular hospital room by 10 or 10:30. She'll be here until sometime on Wednesday unless something unforeseen crops up, at which time I'll take her home for 6-8 weeks of further recovery.

Update: The wifey AKA Sally was in surgery for an hour and they replaced the hip joint as noted yesterday. It was a side-entry procedure. I guess there are several ways to do this and this is the way her surgeon does it. At any rate they had her up and in a chair less than three hours after she was moved to a room from recovery. She wasn't walking per se, just supporting herself. The main achievement was that she never had to use a bedpan. Yes, that's probably TMI but it is very good that she was able to get out of bed to do that, so I'm including it. She's been on the phone and on Facetime and Facebook and is generally having a great time for someone who can't get out of bed without assistance. This hospital is like a hotel. They have a "room service" menu and the food is outstanding (except they won't let her have certain things because she's on the "diabetic" diet. No chocolate chip cookie, but no-sugar-added chocolate ice cream is fine). The nurses and techs are all fabulous, and it's clear they love working there. The docs are docs, plus they have multimegabit wireless access. I was up there all day yesterday telecommuting and never missed a beat. So the story goes that they will kick her loose on Wednesday sometime before noon. Then I bring her home and settle her in the chair we borrowed from my mother. We had a chair that would work from a technical standpoint but it was not comfortable for her to sit in and it didn't have solid sides under the arms, so stuff like the TV remote would fall on the floor if it slid off her lap. So we rederanged [sic] the living room so that she could see the TV from this chair, and actually we like the way the room is set now, so we will probably leave it like that after she recovers. Recovery time is 6-8 weeks, and as I understand it there is a lot of physical therapy involved. In 4 weeks she will go back to work with a walker. In 6 the hip is substantially healed and in 8 the bone should have completely attached to the new joint. The thing we have to be concerned about at this point is dislocation, although as long as she follows four simple rules about how to move, she'll be golden. Apparently they let her wear real clothes today

<u>Day two.</u> The nerve block is still working as are the other meds. The scrambled eggs with cheese are yummy. The staff is wonderful and I get to put on real clothes today instead of the gown! Thanks all for your thoughts, prayers, and love!

All of your positive thoughts combined with my determination are working! I just got out of bed and walked down the hall with the gait belt on but my pt just being there if i needed him! I walked with the walker myself! Whoo hoo! Thanks!

Phoenix Bridegroom: Phoenix Faith had her check-up Monday at Memorial Hospital in South Bend. We are thrilled to share that she continues to amaze us with perfect blood counts! The oncology clinic staff was overjoyed to see her, & so pumped to hear Phoenix say how she is looking forward to school. Her doctors have given the green light for a full day of 1st grade, & showered her with a ton of new school supplies.

This summer has been so so SO awesome for this family. Our most exciting news comes from our new friendship with <u>Make-A-Wish foundation who will be sending our family to Disney World at the end of September.</u> We have much to celebrate & thank you all for your continued support & prayers! As a young person, I was totally freaked out by anything related to death or dying. It just wasn't something that was discussed in my family. It wasn't until I was older that I realized nobody talked about it! In our modern Western society we are so obsessed with youth and beauty and spending and living that we ignore our inevitable demise as much as humanly possible. All the avoidance around the topic of death and dying is a reflection of our denial of it.

When I was almost 40, I became a hospice volunteer. Of course I was nervous when I started (what would I say?), but something amazing happened. My own fear of death lightened up a lot. And my perspective on life changed dramatically. Today's quote reminds of me of the lessons I learned as a hospice volunteer. Here's how thinking about death can help you live a more fulfilled life. Consider what a hospice nurse found when she interviewed dying about their regrets in life. They said:

- 1. I wish I hadn't worked so hard.
- 2. I wish I'd expressed my feelings more.
- 3. I wish I'd stayed in touch with my friends.
- 4. I wish that I had let myself be happier.
- 5. I wish I'd had the courage to live a life true to myself, not the life others expected of me.
